



Tourist eVisitor Visa Application Pack

Thank you for requesting an application pack for an Australia Tourist eVisitor Visa.

Please complete the following three sections and then return the application pack and all supporting documents to Visa Australia Ltd.

The Australia eVisitor Visa is valid for travel to Australia for tourist and business purposes. It is valid for 12 months and permits multiple entries of up to 3 months per entry.

Those who have been convicted of a crime and the resultant sentence totalled 12 months or more will **not** be eligible for an eVisitor visa for Australia and are advised to contact Visa Australia to discuss their options.

If you are an Australian dual citizen, you must travel to Australia on an Australian passport. Even if you no longer hold a valid Australian passport, you will still be classed as an Australian citizen and will be required to renew your Australian passport in order to travel to Australia.
